Commissioners Proceedings

On July 2, 2019, at 8:30 a.m. the Board of Commissioners of Cavalier County, North Dakota, met at the Cavalier County Courthouse in regular session, with all members present. The meeting began with the Pledge of Allegiance. Chairman David Zeis called the meeting to order and proceeded as follows:

Zeis asked if there were any changes to the agenda. Nick Moser made a motion to approve the agenda, seconded by Austin Lafrenz; motion carried. Stanley Dick made a motion to approve the minutes, seconded by Austin Lafrenz; motion carried.

Nick Moser discussed budgeting for a gravel project on County 33. It was decided to get quotes from area contractors. David Zeis stated he would have Terry Johnston get quotes for a gravel project on County 6.

Debra Olson, Domestic Violence and Abuse Center, met with the commissioners and requested an increase in the funding they have been receiving from Cavalier County from \$6,000/year to \$10,000/year. The commissioners asked Olson to follow up and let them know if Walsh and Pembina Counties approve increasing their contributions, and also asked for a breakdown on the percentage of usage from each county.

Stephanie Bata, Tax Director, met with the commissioners to review the map factor changes in Elgin and Manilla Townships. The legislative changes for qualifying for farm exemptions for 2020 were also discussed.

Terry Johnston, Road Supervisor, met with the commissioners and reviewed progress on the current road projects. Nick Moser made a motion to approve the Resolution to accept the bid from West River Striping Co. for \$81,883.74 (20% county share) for the striping project, seconded by Austin Lafrenz, motion carried.

Culvert requests from Fremont Township were reviewed. Johnston stated he had inspected the current concrete box culverts and felt they were structurally sound. It was discussed that any repair to the box culverts would be the township's expense and that the county would only cost share if they were replaced. Nick Moser made a motion to deny the two culvert requests from Fremont Township, seconded by Stanley Dick, motion carried.

The traffic counters on County 55 and County 13 were discussed. David Zeis stated that he had a request for slow children signs on County 6. The commissioners were in agreement. There was discussion on the repairs and maintenance that needed to be done to the Sarles snowplow truck. Items to put on the public auction were discussed. Cell phones for the roadmen were discussed. David Zeis stated he would have Karen Kempert, Emergency Manager check on the cost of a cell plan for the roadmen. Later in the meeting Nick Moser made a motion to require all blade operators to have a cell phone whether it is partially reimbursed by the county or supplied by the county by August 1, 2019, seconded by Stanley Dick, motion carried.

Greg Fetsch, Sheriff, met with the commissioners and stated that Lindsey Gellner would be willing to be Deputy Coroner when Dr. Emerson is not available. **Nick Moser made a motion to appoint Lindsey Gellner as Deputy Coroner, seconded by Greg Goodman, motion carried.** Fetsch informed the commissioners that Langdon City had approved the proposed policing contract. Fetsch also informed the commissioners that he had been contacted by Towner County to see if Cavalier

County wanted to share our scales and possibly an employee to run them. It was decided that the county would not at this time.

Daren Christianson, Langdon Area Schools Superintendent, met with the commissioners and informed them that the school would be having a special election on October 1st to vote on increasing the maximum school building fund levy from 5 mills to 15 mills. If the vote passes, it will not have a sunset clause. Christianson reviewed various updates needed in both schools and the proposed project that has been put together with CTS Group.

Nick Moser informed the commission about an open record request he had received and stated he had fulfilled the request and would keep copies of what was sent.

There was discussion on the Social Services redesign and the proposed zone. Various questions were discussed that would be asked at the July 8th meeting in Walsh County with the state.

Austin Lafrenz made a motion to transfer \$39,000.00 from Special County Highway Fund to Road and Bridge Fund, seconded by Stanley Dick, motion carried. Greg Goodman made a motion to transfer \$625.00 from Road and Bridge to Road and Bridge Equipment Replacement Fund, seconded by Nick Moser, motion carried. Greg Goodman made a motion to transfer \$1,466.54 from Road and Bridge Fund to Road and Bridge Excess Levy Fund, seconded by Nick Moser, motion carried. Nick Moser made a motion to transfer \$146.65 from Road and Bridge Fund to Road and Bridge Equipment Replacement Fund, seconded by Stanley Dick, motion carried.

Austin Lafrenz made a motion, seconded by Greg Goodman to review and approve the following audit of claims; motion carried:
