**October 2, 2025**

The Cavalier County Water Resource Board held a regular meeting on October 2, 2025, at 8:00 am in the Commissioners Room at the Cavalier County Courthouse. Chairman Brian Hardy called the meeting to order with Shauna Schneider, Ordale Morstad, Bruce Roder, Craig Borgen and Paula Cunningham present.

Ordale made a motion to approve the agenda with a second from Shauna. Motion unanimously carried.

Shauna made a motion to approve the minutes from September 11<sup>th</sup>, 2025, meeting. Ordale seconded the motion. Motion unanimously carried.

### **Old Business:**

Paula gave an update on the drain balances that have been completed.

Rec area update: Water is off and everything has been winterized. Tanks are drained already. Docks are still in and will be removed when the weather changes. Remainder of trees that are bad will need to be cut down, Taylor is aware that this will need to get done this year yet.

Brian stated that he talked with Mikkelsen's for the clean out at Binky Lake. Chris will notify Brian a couple of days prior to doing so he can contact Matt at Fish and Wildlife as he needs to be there when the clean out happens. Bruce will be the Water Board representative on site during the project.

### **New Business:**

All drain assessments were reviewed by the Board with the current balances.

Ordale made a motion to assess Channel A .46 cents per acre. Craig seconded the motion. Motion unanimously carried.

Bruce made a motion to assess the Osnabrock drain \$3.00 per acre. Shauna seconded the motion. Motion unanimously carried.

Bruce made a motion to assess Hunter Lake Lateral \$2.00 per acre. Shauna seconded the motion. Motion unanimously carried.

Shauna made a motion to assess the Devils Lake Basin .07 cents per acre. Ordale seconded the motion. Motion unanimously carried.

Shauna made a motion to keep the drains and their balances separated instead of combining them. Bruce seconded the motion. Motion unanimously carried.

Shauna made a motion to approve the security of pledges as presented. Ordale seconded the motion. Motion unanimously carried.

Shauna made a motion to approve the vouchers as presented with a second from Ordale. Motion unanimously carried.
